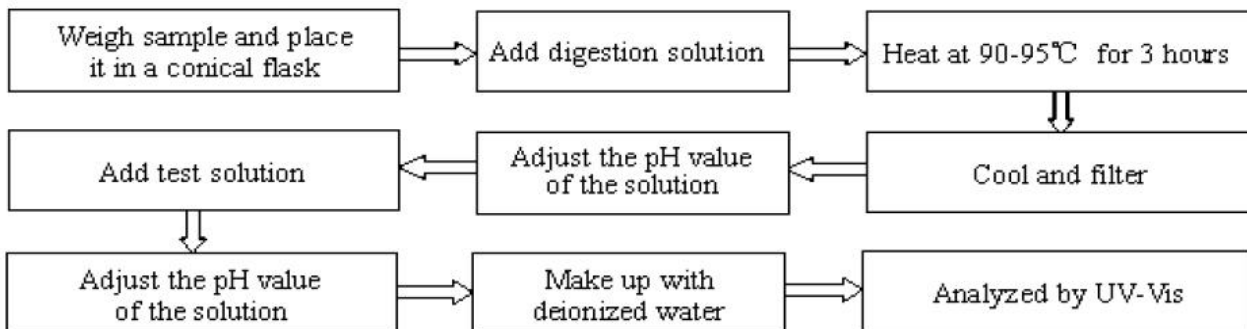

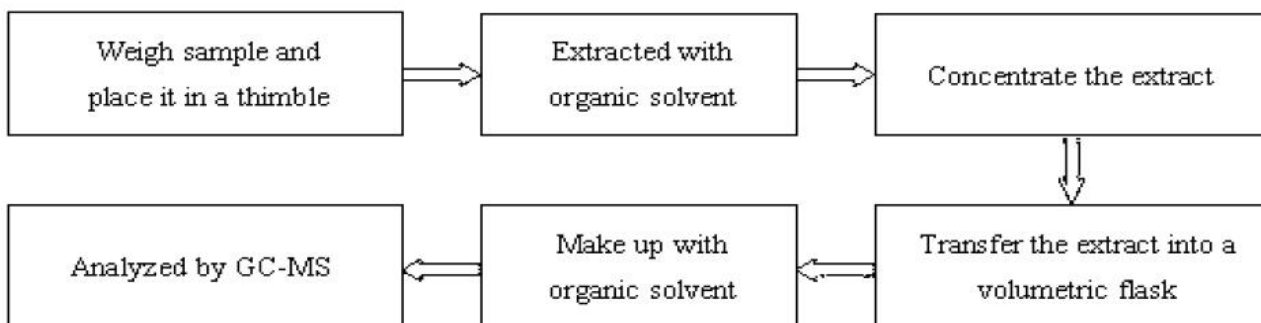
**2. Mercury(Hg)**

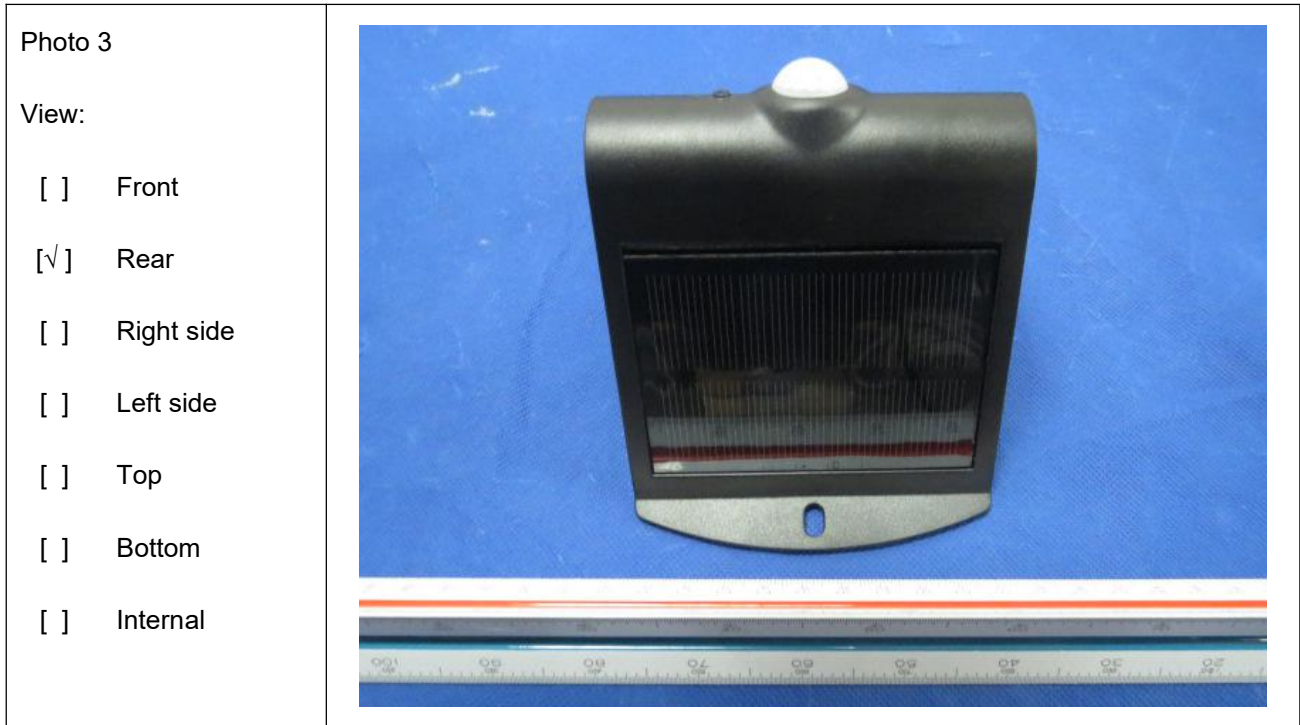




